

General: Plumbing work will not be started until the permit has been issued. All installations shall be in conformance with the Plumbing Code. No work shall be concealed until it has been inspected.

All inspections are scheduled on-line at www.plymouthtwp.org through your AMG account.

EXPIRATION OF PERMIT: A permit remains valid as long as work is progressing and inspections are requested and conducted. A permit shall become invalid if the authorized work is not commenced within six months time of commencing the work or date of last inspection.

SUSPENDED PERMITS CANNOT BE REFUNDED OR REINSTATED.
