**I. UNFINISHED BUSINESS**

- 1) Amendment to Water and Sewer System Ordinance  
Ordinance Number C-2011-05  
Second reading

Attorney Cronin explained that the amendment is to have the water and sewer rates and fees removed from the ordinance and have them included in the Township's fee schedule.

Moved by Mr. Doroshewitz, seconded by Ms. Arnold, to approve the second reading of Ordinance No. C-2011-05, amending the Water and Sewer System Ordinance, Chapter 73, Article 1, Sections 73.010 through 73.070. Ayes all on a roll call vote.

**J. NEW BUSINESS**

- 1) DPW Foreman Employment Agreement

Mr. Reaume noted the extensive qualifications of Mr. Mike Karll who is a recent retiree from Canton Township.

Moved by Ms. Arnold, seconded by Mr. Kelly, to approve the employment agreement with Mike Karll for the vacant position of DPW Foreman, and authorize the Supervisor and Clerk to sign the agreement. Ayes all.

- 2) Detroit Water and Sewer Department Amendment Number 1 to  
Water Service Contract

Mr. Reaume explained that lengthy negotiations with DWSD executive staff; new Wayne County appointee to the Board of Water Commissioners, Jim Fausone; and representatives from Mayor Bing's office, resulted in new rate factors that will mean considerable savings for the Township.

Mr. Reaume thanked Mr. Fausone, who was present at the meeting, for his efforts in these negotiations. He also indicated the recommended hours for watering remain from 12 noon until 6 p.m. and from midnight until 6 a.m.

Mr. Edwards thanked Mr. Reaume for his part in the negotiations and noted that if residents begin to conserve water, it will negatively affect water costs to the Township.

Moved by Mr. Kelly, seconded by Mr. Edwards, to accept the Offer of Settlement from DWSD and approve the attached Amendment No. 1 to the Water and Service Contract between the City of Detroit and the Charter Township of Plymouth, and authorize the Supervisor and Clerk to sign the amendment. Ayes all on a roll call vote.

**3) Water and Sewer Rates**

Mr. Martin Olejnik of Plante and Moran reviewed the Water and Sewer Fund financial information, which resulted in their recommended rate increase of \$.70 per one thousand gallons.

Within the Charter Township of Plymouth Comprehensive Fee Schedule, Mr. Edwards moved to revise the water rate from \$3.10 to \$3.80 per one thousand gallons and retain the current sewage disposal rate at \$5.25 per one thousand gallons. Seconded by Ms. Arnold.

The motion was subsequently withdrawn by the maker and supporter upon Mr. Mann's indication that the new water and sewer rates are part of the Comprehensive Fee Schedule, which is the next item for adoption.
